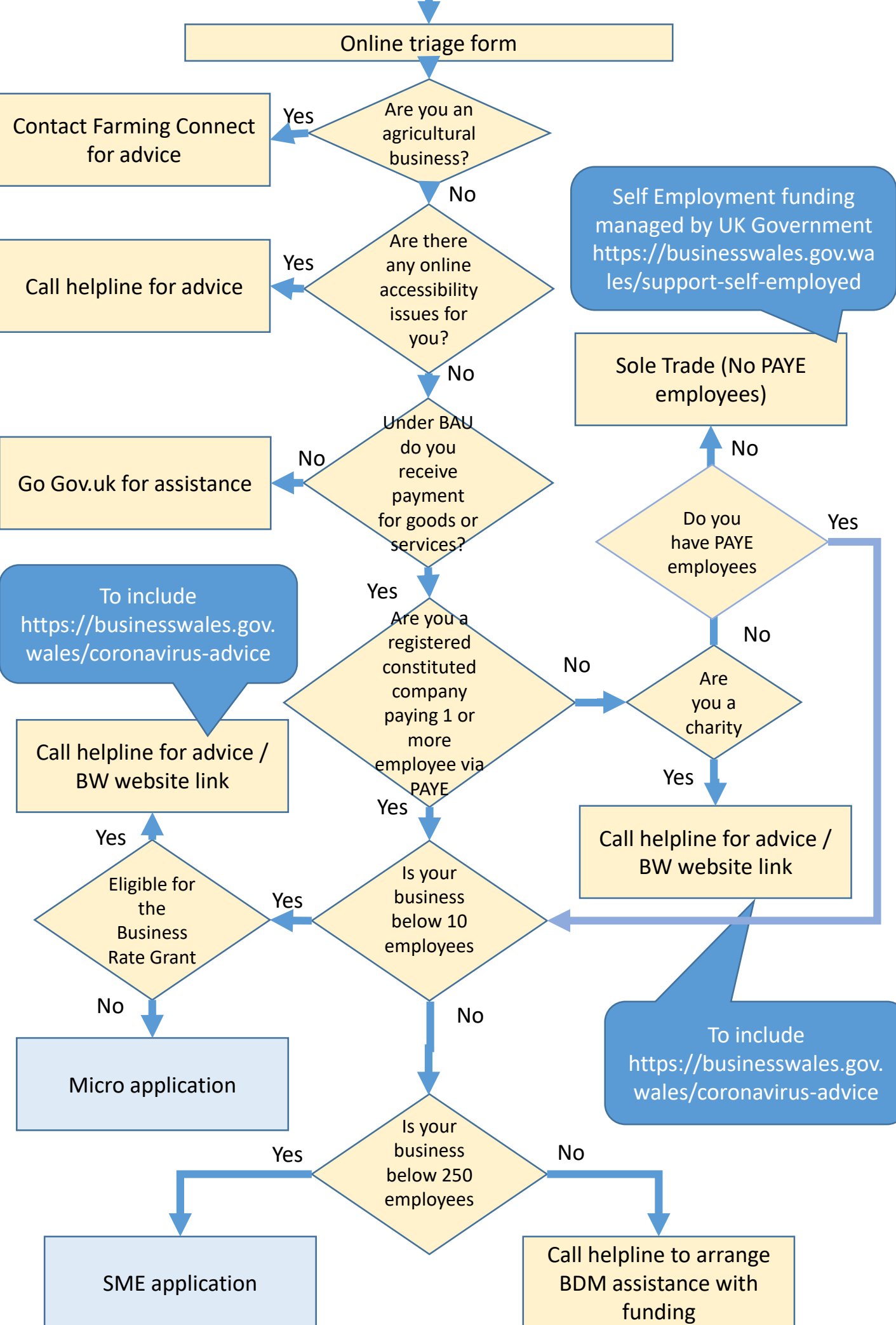

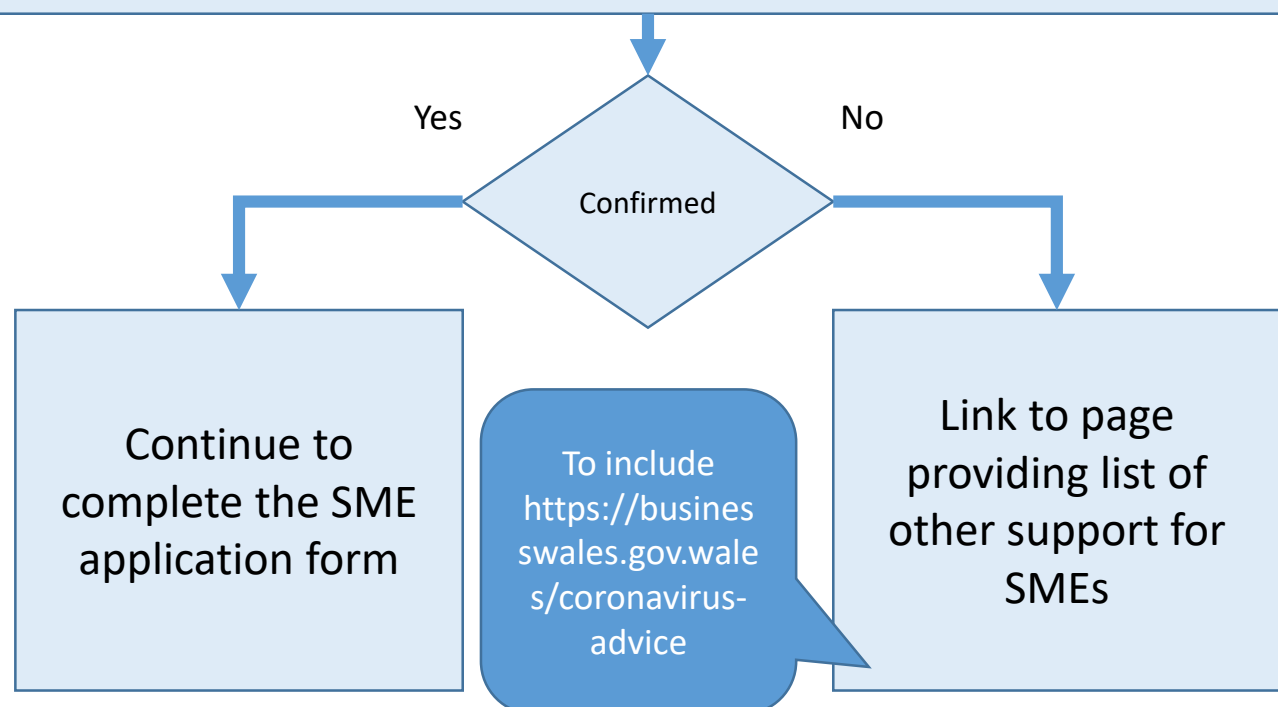
These will be tick box questions to prove they have been read and all agreed.

Does your business satisfy the following criteria?

All points must be confirmed to be eligible to apply for the fund

- Confirmation that funding from any other WG non-repayable grant funding source is not being pursued.
- Have 10 or more Full time equivalent employees but less than 250
- Are VAT registered or exempt, with turnover above £80,000/year.
- Are not eligible for £25k Business Rates Grant or if the applicant has received this grant any funding provided will be deducted from the final amount approved under this scheme.
- Have an operating address in Wales.
- Have experienced a greater than 60% drop in turnover since 1st March 2020.
- Are able to demonstrate a strategy and plan to trade out of crisis.
- Are you already accessing existing funding (Job retention etc) and funds from own, bank, HMRC and DBW finance before applying for this fund .
- In submitting an application for the Resilience Fund I am content for my application details to be shared following GDPR approval with delivery partners of the scheme (Local Authorities and Business Wales)
- If successful I am happy for the name of my business to be published on a recipients of support list on the Welsh Governments web site.

All points must be confirmed to be eligible to apply for the fund

- The business is not eligible for the Business Rate Grant
- Employing between 1 and 9 employees
- Operating address and employ in Wales
- Are able to demonstrate a strategy and plan to trade out of crisis.
- Are VAT registered or exempt, with turnover above £80,000/year
- Have experienced a greater than 40% drop in turnover since 1st March 2020
- Supported businesses must aim to maintain employment for 12 months
- Only one application per businesses
- Evidence of details of reduction in turnover as a result of the Covid-19 outbreak
- Evidence of business address (within the last 3 months)
- In submitting an application for the Resilience Fund I am content for my application details to be shared following GDPR approval with delivery partners of the scheme (Local Authorities and Business Wales)
